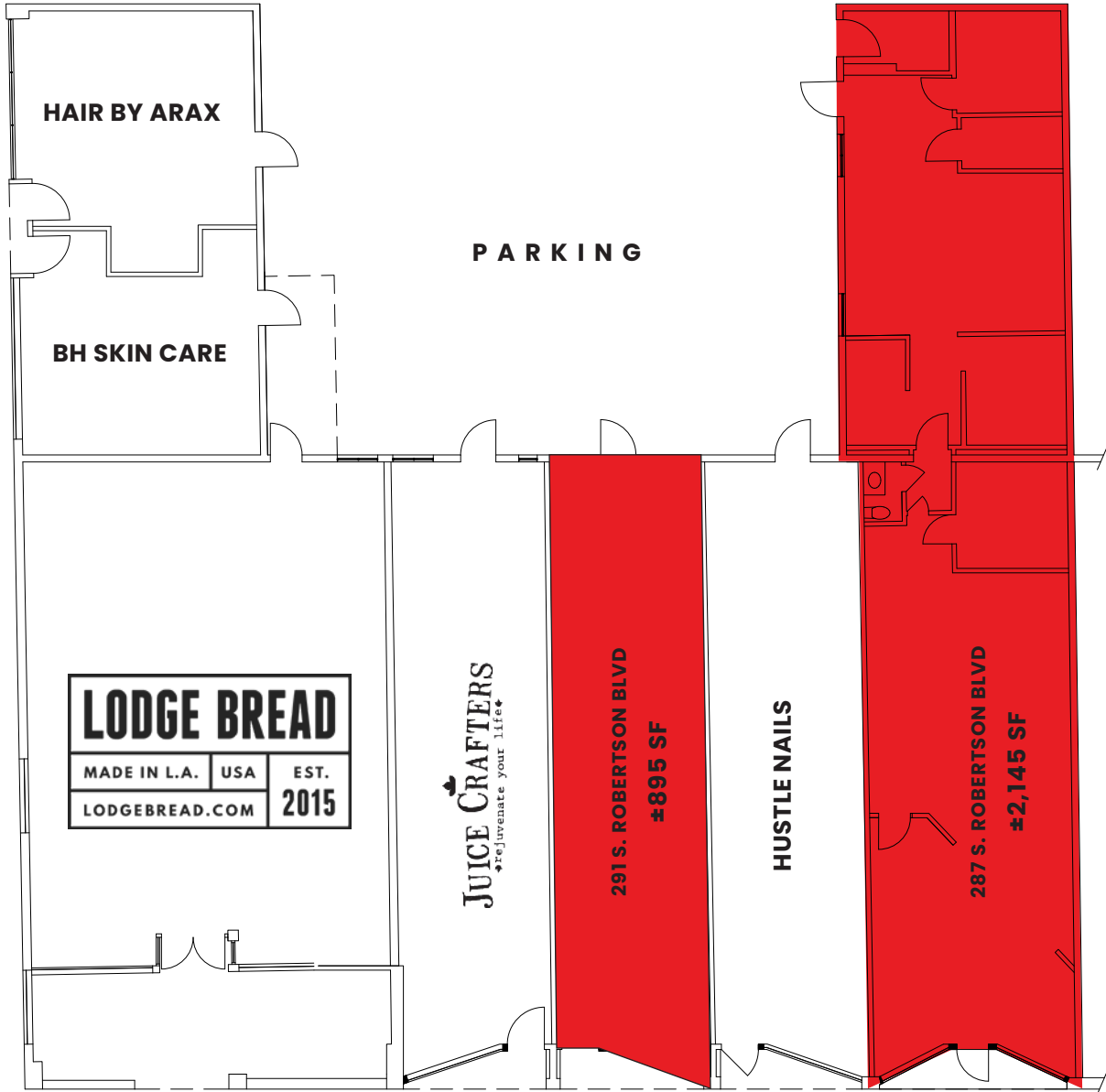


FLOOR PLAN

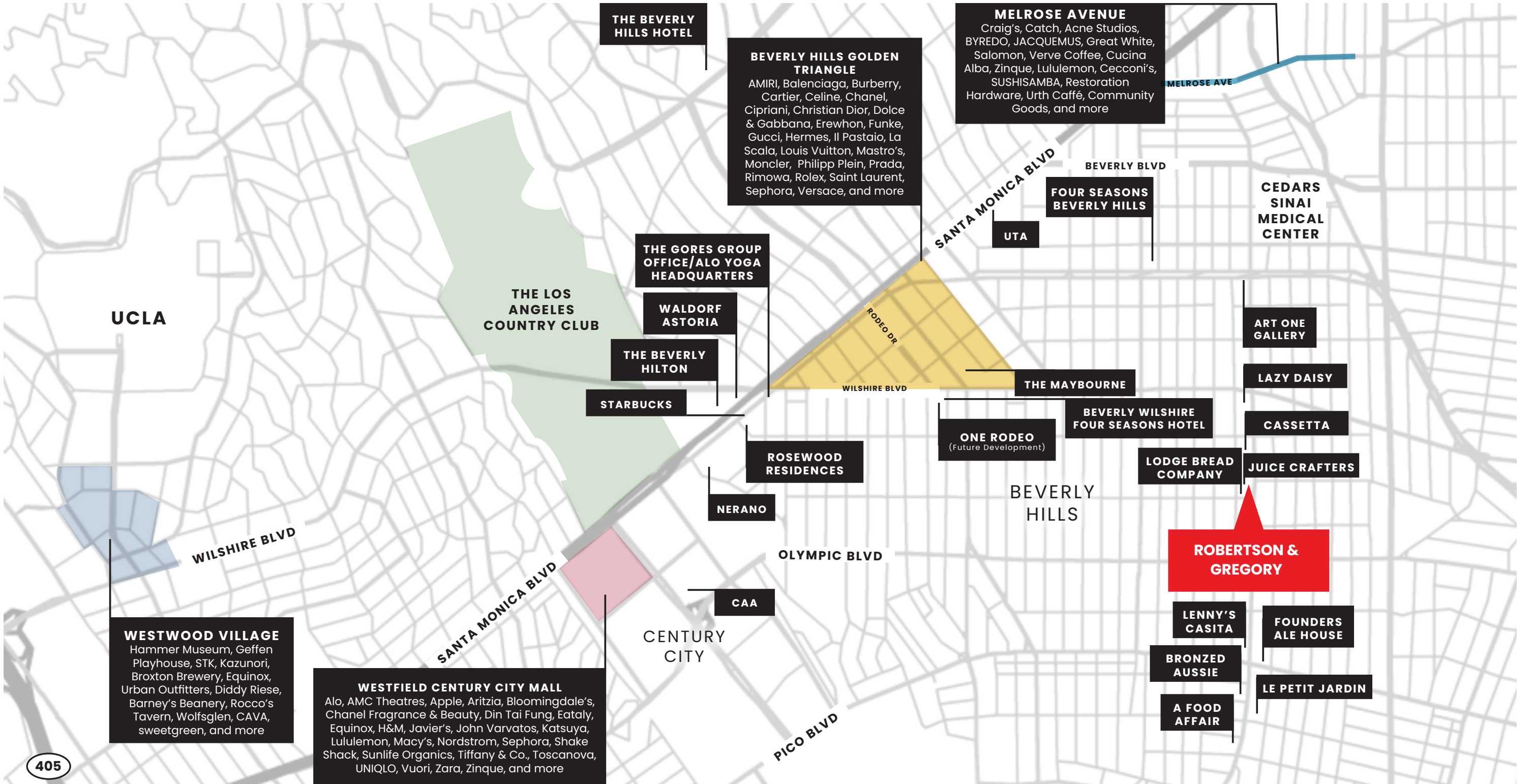
